

Services Summary

Our agency name changed from Second Step to Turnaround, Inc, on March 31, 2000.

Turnaround touched the lives of over 20,000 Marylanders in Baltimore City and County this year. An expanded need for certain services became increasingly evident in 1999, and we responded with additional resources.

For instance, our Domestic Violence services have experienced a tremendous increase and have maintained waiting lists for child victims during the year. Our Community Outreach programs experienced significant growth this year due to the generosity of our supporters and resources.

Since 1984, Turnaround has provided group treatment services to voluntary and court ordered batterers in our Towson and Rosedale Offices. During this fiscal year, we extended our batterers services to more effectively intervene in the cycle of violence. We continue to work closely with the police and the court system, and through our "partner contacts" we monitor treatment effectiveness.

For the first time in the media arena, we partnered with WMAR-TV to create more awareness of the overall issues of Domestic Violence and Sexual Assault. The below mentioned statistical summary was again indicative of the enormity of our regional needs.
